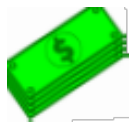

PAYMENT:

Fees are calculated based on a weekly attendance (NOT DAILY). Payments are due on **MONDAYS** in the morning when the child is been picked up, including the first day scheduled attendance. A late fee of \$5.00 –per day will be charged for payments received after MONDAY, NO EXCEPTIONS! Checks cannot be held until funds are available, this will be considered late, and you must add the late fee. There is a charge of \$15 for returned checks, and this amount will have to be CASH, plus the late fee of \$5.00 per day. This will be accepted in the future and only cash payments will be taken. Please note that legal action will be taken for payments owed if necessary.



Pick up & Drop off

Parents need to make sure children are ready to board on time of pick up. The wait time is only 2 minutes, if not ready they will be left behind and it is the parents' responsibility to transport the student. The bus driver will not return to pick up the child. **NO EXCEPTIONS!!!**

At drop off, the driver will wait until the student, no matter what age or grade, walks inside the house.

NOTE:

IF THERE IS HOLIDAY DURING THE WEEK, THIS DAY WILL NOT BE DISCOUNTED; THE PAYMENT WILL REMAIN THE SAME. EXCEPTIONS ARE: SPRING BREAK AND CHRISTMAS BREAK.

IT IS NOT PERMITTED TO EAT WHILE IN THE BUS AS SECURITY MEASURE, THANK YOU FOR YOUR COOPERATION.
